# Background

On 28 September, the Office of the Australian Information Commissioner (OAIC) will join members of the United Nations and Australian states and territories in marking **International Access to Information Day**. This year we are joined by Freedom of Information Commissioner Leo Hardiman PSM KC who commenced his appointment with the OAIC in April 2022, advancing the OAIC's important work to uphold the community's access rights.

This global event is also celebrated as Right to Know Day and recognises the importance of the community's right to know and to access information from governments around the globe.

In October 2019, the 74th United Nations General Assembly proclaimed 28 September as the <u>International Day for Universal Access to Information</u> (IDUAI).

Our right to access Australian Government information is enshrined in the *Freedom of Information Act 1982* (FOI Act) which acknowledges government-held information is a national resource that should be managed for public purposes.

This year's theme chosen by UNESCO is artificial Intelligence, e-governance and access to information. It encourages us to consider how our digital world can improve access to information and enhance **openness through e-governance**.

We encourage Australian Government agencies to mark International Access to Information Day with us, to show support for building both robust e-governance systems and digital platforms that enable access to information for all members of the Australian community.

It's also an opportunity to acknowledge the important role of your agency's FOI practitioners and decision-makers and their work to manage government-held information as a national resource.

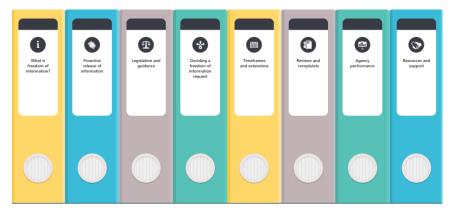

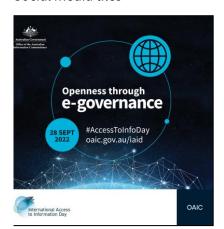
